Provided that, no person shall serve as Chairperson or other Member for more than two terms.

Section 6 (4)

The salary and allowances and other terms and conditions of service of the Chairperson and other Members shall be such as may be specified by the Government.

4. Oath of Office:-

Section 6 (5)

The Chairperson and every Member shall, before entering upon his office, make and subscribe to an oath of office and secrecy in such form and in such manner and before such Authority, as may be specified.

5. General:
